Indicators of activity of multinationals' subsidiaries (FATS) in Romania

Argument and Methodology

This approach constitutes the second part of the research on the presence of subsidiaries of multinational companies in the European Union, with Romanian features.

In terms of methodology, we apply the model with four variables from the first part of the research, seeking to identify:

- The share of FATS in total number of companies;
- The share of FATS turnover in total turnover;
- The share of FATS gross value added at cost of factors in total gross value added
- The share of FATS employees in total employees

Identification of the values of the four variables will be done for each of the seven main sectors of the economy, according to the NIS approach, aligned to the European Union statistics.

Thus, we refer to:

- Mining and quarrying industry
- Manufacturing industry
- Production and supply of electric power, gas, hot water and air conditioning
- Water supply, sanitation, decontamination
- Constructions
- Trade
- Market services

The algorithm of ranking model of sectoral dependence on FATS remains the one used in the first part of our research.

The research used as a source of information the latest data published by NIS in the work Results and performance of businesses, edition 2016, with results in 2014. We verified that the NIS data coincide with those reported for Romania by Eurostat earlier this year.

Also in this section of the research, we present for the first time with the direct support of the President of NIS the gross result of the financial year for all FATS companies, as well as for each of the seven main sectors of the economy in 2014.

a. Sectoral economic dependence on FATS companies in 2014

Our conclusions are:

Multi-criteria ranking clearly demonstrates the strong asymmetry of influence of FATS companies in key sectors of the Romanian economy. Thus, of the seven main sectors of national economy, the mining and quarrying industry and the manufacturing industry are largely dependent on the FATS companies. These two sectors concentrate almost half of turnover (40.6%), of gross value added at factor cost (46.0%) and more than half of the number of employees (52.4%) of all the FATS companies resident in Romania.

It should be emphasized that this dependence is achieved by only a number of **4895** FATS companies, representing **16.3%** of all FATS companies operating in Romania.

The explanation is that these two sectors recorded the highest value of the ratio of the average number of employees / FATS company and non-FATS company (7.1 in the mining and quarrying industry and 7.4 in the manufacturing industry). The number of employees / FATS company is the largest of the seven economic sectors (165.1 in the mining and quarrying industry and 110.3 in the manufacturing industry). Careful analysis of dependence of the main economic sectors on FATS also captures the fact that in the 6 sectors where the share of FATS turnover exceeds 20% the leading companies are FATS:

- S.C. OMV Petrom SA in the mining and quarrying industry
- S.C. Automobile Dacia SA in the manufacturing industry
- E. ON Energie România in electric and thermal power, gas
- S.C. Orange România in market services
- S.C. OMV Marketing SRL in trade
- S.C: Apa Nova București SA in water supply, sanitation, decontamination.

In 2014, the constructions sector, with the lowest share of FATS, had a Romanian leading company: Compania Naţională de Autostrăzi şi Drumuri Naţionale din România SA.

b. The gross results of financial year 2014 of the FATS companies

In 2014, the system of companies resident in Romania consisting of the seven sectors previously analyzed has recorded a gross profit of **34.5** billion Lei, at **3.13**% a rate relative to the total turnover.

The non-FATS resident companies recorded a gross profit of **26.3** billion Lei, at **4.60**% a rate relative to their turnover.

The FATS resident companies recorded a gross profit of **8.2** billion Lei, at **1.54**% a rate relative to their turnover.

For 2014, the gross profit distribution was:

• Non-FATS companies 76.5 %

• FATS companies 23.5 %.

Distribution by the 7 main sectors of the economy of the gross result for the FATS companies in 2014 was as follows:

One may notice that from among the seven sectors, five are profitable. The highest losses (volume and loss rate) were recorded by the constructions sector, with the lowest dependency on FATS. The mining and quarrying industry and the manufacturing industry cumulates 82.3% of gross profit of the FATS companies and fully confirm the essential role they have in the Romanian economy.

The structure of exports of goods of Romania and, finally, external competitiveness, fundamentally depend on the FATS companies operating in these two sectors.
